PUBLIC MEETING on MONDAY, APRIL 14 in MAYFIELD CHURCH HALL, at 8.00pm


Michael Clarke (Lecturer in Politics) writes:-We feel there is little to be gained by piecemeal consideration of the matter. A true appreciation of the situation can result only from thinking the subject out in co-operation with neighbouring areas. District Councils are responsible for drafting schemes for their areas before May 1976 and a meeting has already been held for people living in District Wards of Councillors Kean, Houston and Ritchie - from EGA to Prestonfield, and from Blackford Hill to St. Leonard's. A steering committee was formed which included a group from the EGA. It considered, in the first instance, alternate schemes of Community Council boundaries within that area. Once the scheme is approved, it is up to 20 people in each area designated as the base for a Community Council to request that one be set up.

The definition of function given in the Act is in Section 51:-

"In addition to any other purpose which a Community Council may pursue, the general purpose of a Community Council shall be to ascertain, co-ordinate and express to the local authorities for its area, and to purpose authorities, the views of the community which it represents, in relation to matters for which those authorities are responsible, and to take such action in the interests of that community as appears to it to be expedient and practicable.

At the meeting on April 14, these schemes will be discussed, and amended if need be; and an agenda will be worked out for the next round of discussions.

### national trust house



St Alban's Road - between 61 and 63 Viewpoint Housing has applied for permission to erect sheltered housing up to three storeys high.

Dick Place - plot formerly Craigmount Sc. of - this plot belongs to James Miller & Ptns., who were granted outline planning permission in 1969 and now have applied for renewal. A "blanket" tree preservation order was made on the whole site, but after the original planning permission was granted. There is a dispute between James Miller & Itns., and Edinburgh Corporation about whether development was begun between 1969 and the second application. If so, then the tree preservation order is ineffective: if not so, then the order can be enforced. Meanwhile, local residents are watching to see the trees are not endangered.

Ratcliffe Terrace - Opposite the end of Grange Loan - this property lies just out the Association boundary but it obviously affects the East Grange area. The old cottages are in the 'C' grade of building of historical or architectural interest which has no practical effect on development. They are at present being advertised for sale as a development site together with the ground behind. The Cockburn Association pressed the Corporation to put a Building Preservation Notice on them: this prevents demolition for six months whilst their future is decided.
