THE CITY OF EDINBURGH COUNCIL (GRANGE ROAD AREA, EDINBURGH)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2021 -
TEMP/21/110

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (Grange Road Area, Edinburgh) (Temporary Road Restriction and Traffic Regulation) Order 2021" and shall come into operation on the Fourteenth day of June Two thousand and twenty-one and shall remain in force up to and including the Twelfth day of September Two thousand and twenty-one.
2. Save as provided in Article 3 of this Order, to facilitate carriageway resurfacing, footway and cycleway reconstruction and new traffic signal infrastructure installation works, no person shall, (as signed as affected by the works): -
 - (a) drive or cause or permit to be driven any vehicle on any part of the roads described in Schedule 1 to this Order; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the parts of the roads specified in Schedule 2 to this Order, prohibitions will apply to both sides of the roads.
3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the works.
4. Whilst this Order continues in force, The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018 shall be suspended in so far as any of the roads described in Schedule 2 of this Order are effected.
5. The alternative route for through vehicular traffic is via Kilgraston Road, Dick Place, Findhorn Place, Tantallon Place, Cumin Place, Grange Road, Hatton Place, Chalmers Crescent, Lauder Road, Grange Loan, Blackford Avenue, Grange Terrace, Fountainhall Road and South Lauder Road.

SCHEDULE 1
ROAD CLOSURES

(i) Grange Road, from its junction with Chalmers Crescent eastwards to its junction with Tantallon Place; (ii) Lauder Road, from its junction with Hatton Place southwards to its junction with Dick Place; (iii) Mansionhouse Road, at its junction with Grange Road; (iv) Tantallon Place, at its junction with Grange Road; (v) Cumin Place, at its junction with Grange Road; (vi) Hatton Place, from its junction with Chalmers Crescent eastwards to its junction with Mansionhouse Road; (vii) Dick Place, from its junction with Mansionhouse Road westwards to its junction with Wyvern Park; (viii) Grange Loan, from its junction with Grange Crescent westwards to its junction with West Grange Gardens; and (ix) St Thomas Road, at its junction with Grange Loan.

SCHEDULE 2
ROADS ON WHICH WAITING AND LOADING AND UNLOADING WILL BE
PROHIBITED

(i) Grange Road, from its junction with Chalmers Crescent eastwards to its junction with Tantallon Place; (ii) Lauder Road, from its junction with Hatton Place southwards to its junction with Dick Place; (iii) Hatton Place, from its junction with Chalmers Crescent eastwards to its junction with Mansionhouse Road; (iv) Dick Place, from its junction with Mansionhouse Road westwards to its junction with Wyvern Park; and (v) Grange Loan, from its junction with Grange Crescent westwards to its junction with West Grange Gardens.
