Hi John,

In connection to your application for tree work at 10 Grange Road (22/00965/TCO) I wanted to raise the concerns over the proposed felling of the mature lime tree (T3) located in the rear garden of the property. You are proposing felling for two reasons: one to avoid damage to the neighbouring property and two to allow a new driveway to be constructed. The tree has clearly been pruned back previously to clear the branches away from the neighbouring house and this could be done again. If the tree is to be felled to accommodate a new driveway, then this would need to be assessed as part of a planning application and thus it would be premature to fell the tree in advance.

You have two options here. You can agree to retain the tree (T3) and submit description for potential pruning works or you could withdraw the application to fell the tree and I shall process the application without this tree. If I don't hear back from you by 21<sup>st</sup> March 2022 I shall treat the application as having been withdrawn.
